National Taiwan University Student Association Candidate Registration Regulations

Subject: This is the notice of "The National Taiwan University 2024 First Semester (Autumn Semester 2024) Election" including types of elections, the voting date, the voters of different types of elections and their numbers, seats-to-be-elected and reserved seats, registration period, documents-to-hand-in and registration fee, the members of Election and Recalling Execution Commission, and other reminders.

According to Article 22 of "National Taiwan University Student Association Election and Recall Act".

- 1. The Election is expected to be held on Friday, December 6th, 2024.
- 2. Members of Election and Recalling Execution:

Commission Chairperson: TANG, HENG-CHUN.

Deputy Chairperson: HSU, TSU-CHIN.

Members: LIN, YAN-JUNG/LIN, CHAO-CHUN/CHEN, HUNG-YU/CHANG,

HSIANG-CHUN/ HUANG, JIE-SEN/ LO, WEI-CHE.

- 3. Types of elections, the voters of different types and their numbers, and seats-to be-elected:
 - (1) Representatives of the University Student Council:
 - a. Voters: all NTU students.
 - b. Electoral District: Students should be the voters of their own colleges' districts, unless they have applied for changing it before.
 - c. Seats and the numbers of voters of each college:

- d. Term in office: from February $\mathbf{1}^{st}$, 2025 to January $\mathbf{31}^{st}$, 2026.
- e. The term in office for by-elected representatives: from February $\mathbf{1}^{st}$, 2025 to July $\mathbf{31}^{st}$, 2025.
- 4. Registration period, documents-to-hand-in, and fee
 - (1) Registration period: from now until 23:59 on Tuesday, November 5th, 2024. NO EXTENSION GIVEN.
 - (2) Officially register as a candidate by completing the registration process through the link in Appendix 1.
 - (3) Information to fill out or documents to hand in

- (4) After the deadline of registration, no additional documents or modifications will be accepted (except for items requested by the Election and Recalling Execution Commission).
- (5) Registration fee: no deposit or additional fee required.
- 5. Reminders for applicants:
 - (1) Candidate qualifications: according to Article 14 and Article 14-1 of "National Taiwan University Student Association Election and Recall Act," those who are not qualified to be a candidate,
 - a. Members of the Election and Recalling Execution Commission,
 - b. Members of the Election and Recalling Control Committee, polling staff,
 - Student Representatives with an expected unexpired term of office,
 and
 - d. Those who have been deprived of public rights, are not admitted to register as the candidate, neither of the President of the University Student Association, nor of the Representatives of Student Council.
 - (2) Candidate numbers will be given according to the order of registration.
 - (3) One could by no means publish anything related to the candidates or public opinion poll, from 00:00 December 6th until the ballot boxes are sealed.
 - (4) Applicants cannot withdraw their registration.
 - (5) Candidates must set up a budget account for their campaign and report their budget, revenue, and expenses to the Election and Recall Commission of the

National Taiwan University Student Association. The campaign budget for every candidate for the President of the University Student Association cannot exceed the amount of \$50,000 NTD, and for every candidate for the Representative of the University Student Council cannot exceed the amount of \$10,000 NTD. Both of them will not be allowed to receive any donations from outside National Taiwan University or from any other candidate from their same electoral district.

- (6) One could only register as the candidate, either of the President of the University Student Association, or of the Student Representatives of the University Students Council. Registering for both will be treated as invalid for both registrations.
- (7) The head-and-shoulders photo without a hat submitted by the candidate should be in accordance with Article 3 of "National Taiwan University Student Association Election and Recall Act." In case of noncompliance, the candidate should submit a replacement photo within the time limit upon receipt of a letter from the Election and Recalling Execution Commission. If not, the Election and Recalling Execution Commission will disqualify the candidate.

Appendix 2: National Taiwan University Student Association Candidate Registration Regulations

國立臺灣大學學生會候選人登記辦法

2018 年 05 月 03 日學生會選舉罷免執行委員會制定公布全文 7 條 2021 年 03 月 10 日學生會選舉罷免執行委員會修正第 3 條、第 6 條

第一條【法源依據】

本辦法依國立臺灣大學學生會選舉罷免法(以下簡稱本法)第十八條第二項訂定。第二條【登記方式】

本會選舉除另有規定外,選舉罷免執行委員會(以下簡稱選委會)應於第一份 選舉公告上載明受理登記之方式。

第三條【候選人照片之格式】

候選人登記表之照片,應符合下列規定:

- 一、近期內所拍攝。
- 二、為候選人個人之正面證件照或生活照,且不得有其他人之影像。
- 三、無墨跡、摺痕、反光,或其他足以影響辨識之相片缺陷。繳交實體照片者,應以高解析度沖(列)印於至少兩寸之光面相紙上;繳交數位照片者,應提供長、寬至少六百像素之影像。

第四條【在學證明之格式】

以數位格式繳交在學證明者,應提供自本校網站線上申請下載之原始檔案, 或 紙本在學證明之掃描件。

在學證明應於當次選舉候選人登記期間內申請。

第五條【保證金之收取】

選舉訂有規費或保證金者,候選人應依公告之期限與方式,向選委會或指定 之代收機構繳納之。

第六條【不合程式之效力】

登記表件不合規定者,選委會應命其在合理期間內補件或修正至多一次;逾期未補正者,應拒絕受理其登記。

第七條【施行日期】

本辦法自公告日施行。
